In accordance with Article 70 of the Law on Public Procurement (Official Gazette B&H, number 39/14) and in reference to Article 21, paragraph (1), item (2) of the Rule Book on Procurement of Goods, Services and Works of PC Sarajevo International Airport LLC Sarajevo, Article 45 of the Articles of Association of PC Sarajevo International Airport LLC Sarajevo, and based upon the Report and a recommendation of the Committee for Implementation of Public Procurement Procedure for goods: Delivery of original spare parts and provision of service for maintenance and repair service for air bridges manufactured by AVIOBRIDGE (for a period of one year), number 04-6-04-7-649-14/21 of 21 July, 2021, the Management Board of PC Sarajevo International Airport LLC Sarajevo on its 39th session held on 23 July, 2021 made the following

DECISION

1

The offer by the supplier SPIE NEDERLAND B.V. Breda, Netherlands for the procurement of goods: Delivery of original spare parts and provision of service for maintenance and repair service for air bridges manufactured by AVIOBRIDGE (for a period of one year), registered at the Procuring Entity's protocol under number 06-04-7-649-6/21 of 15 July, 2021, which offered 11.454,00 EUR/ i.e. 22.402,07 BAM, without VAT, for the above mentioned goods, is hereby accepted.

After the completion of deadlines for revision, the Procuring Entity shall invite the selected supplier for the purpose of signing the contract on procurement of goods and service, by which mutual rights and obligations in reference to the procurement from item I of this Decision shall be regulated.

Grounds for Decision

Acting in accordance with Articles 17 and 18 of the Law on Public Procurement, and in the aim of choosing the most favourable offer for the procurement of goods: Delivery of original spare parts and provision of service for maintenance and repair service for air bridges manufactured by AVIOBRIDGE (for a period of one year), the Director of PC Sarajevo International Airport LLC Sarajevo made the Decision number 02-1-04-7-649-3/21 of 15 March, 2021 on launching the procurement procedure for the goods concerned and appointed the Committee for Implementation of Procurement Procedure by the Decision number 02-1-04-7-649-5/21 of 7 July, 2021.

The Procuring Entity, acting in accordance with the above mentioned Decision, sent an invitation for submission of qualifying documents and commercial offer required for the implementation of Negotiating Procedure without a publication of procurement notice, i.e. it send an invitation for negotiations to the address of the supplier SPIE NEDERLAND B.V. Breda, Netherlands, taking into consideration that the above mentioned supplier is also an exclusive service provider and distributor of the goods concerned for Bosnia and Herzegovina.

The supplier SPIE NEDERLAND B.V. Breda, Netherlands submitted the requested documentation and the offer at the Protocol Department of PC *Sarajevo International Airport*, until the deadline set, i.e. until 20 July, 2021, 12:30, the same was registered at the Procuring Entity's protocol, under number 06-04-7-649-6/21 of 15 July, 2021.

The same day, the Committee, without the presence of the supplier's representatives, did the analysis of the submitted offer, reviewed the list of qualifying documents and stated that the supplier concerned, in its initial offer, submitted the documentation required for Negotiating Procedure.

The Committee reviewed the prices quoted in the supplier's offer and stated that the supplier offered the prices for the goods and service concerned as follows:

Labour cost:

- 1. Standard annual inspection of the air bridges (2 air bridges), with issuance of certificate for use **5.820,00 EUR (11.382,93 BAM)**
- 2. Repair of damaged part of the air bridge, on location 5.634,00 EUR (11.019,14 BAM)
